**RESOLUTION ESTABLISHING A MEMORIAL DAY COMMITTEE FOR LUMBERTON TOWNSHIP**

**WHEREAS**, since 1885, Lumberton Township has commemorated Memorial Day with a solemn ceremony and other activities including a parade; and

**WHEREAS**, the people of Lumberton Township and the Township Committee want and intend to continue this tradition of recognition of those who made the ultimate sacrifice; and

**WHEREAS**, the ceremony and other Memorial Day activities have traditionally been organized by volunteer organizations within Lumberton Township;

**WHEREAS**, the people of Lumberton Township and the Township Committee want and intend to continue the tradition of volunteerism in the organization and running of the Memorial Day ceremony and events; and

**WHEREAS**, the people of Lumberton Township and the Township Committee recognize that coordination among the various volunteer organizations involved in the planning of the Memorial Day ceremony and activities and the Township government will be needed for the continued success of these events.

**NOW, THEREFORE BE IT RESOLVED** that there shall be a Memorial Day Committee for Lumberton Township established on this 3<sup>rd</sup> day of January, 2017, consisting of:

- The Mayor and a representative of the Township Committee
- The Township Clerk
- The Chief of Police and/or his designated representative
- The Chief of the Lumberton Fire Department and/or his designated representative
- The Chief of the Lumberton Emergency Squad and/or their designated representative
- The President of the Lumberton Historical Society and/or their designated representative
- A Representative of the Last Man's Club
- The President of the Lumberton Civic Association and/or their designated representative
- A Representative of Burlington County Military Affairs Commission
- A Representative of the Lumberton Public Works Department
- Up to three citizens of Lumberton, who may be appointed at the discretion of the Mayor
