

AN ORDINANCE OF THE TOWNSHIP OF LUMBERTON, IN THE COUNTY OF BURLINGTON, NEW JERSEY, REAPPROPRIATING CERTAIN MONIES FROM PREVIOUSLY ADOPTED BOND ORDINANCES AND PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS AND RELATED EXPENSES IN AND FOR THE TOWNSHIP AND APPROPRIATING \$38,900 THEREFOR.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF LUMBERTON, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than

two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The amount of \$54,944.78 from Bond Ordinance 2013-08-007 of the Township, remaining as balances in the bond ordinance heretofore and no longer needed for their intended purposes, is hereby cancelled. Such sum is hereby returned to the Township’s General Capital account.

Section 2. From the Township’s General Capital Account, there is hereby appropriated the sum of \$38,900 for the following purposes:

PURPOSE	APPROPRIATION
HVAC upgrades to Township Buildings	\$20,000
Acquisition of wood storm windows for Township Historical Society	\$8,000
Acquisition of photocopier/scanner for Township Fire Department	\$3,400
Engineering and design services for renovation/construction for Township Fire Department	\$7,500
TOTALS	\$38,900

Section 3. The capital budget of the Township is hereby amended to conform with the provisions of this amendatory bond ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing in full detail the amended capital budget and capital improvement program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, are on file with the Clerk of the Township and available for public inspection.

Section 4. Except as provided herein, Bond Ordinance No. 2013-08-007, as supplemented by this amendatory bond ordinance, remains as finally adopted and otherwise remains in full force and effect.

Section 5. This amendatory bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption as provided by the Local Bond Law.


