**RESOLUTION OF THE TOWNSHIP OF LUMBERTON  
AUTHORIZING THE EXECUTION OF AN  
AGREEMENT FOR AS NEEDED ANIMAL CONTROL SERVICES**

**WHEREAS**, there exists a need for a Licensed Animal Control Officer to perform as needed Animal Control Services when Lumberton Township's appointed Animal Control Officer is either away on leave or unavailable to perform those services; and

**WHEREAS**, New Jersey Animal Control is a local business located in Medford Township and it staff are New Jersey State-certified Animal Cruelty Investigators, New Jersey State-certified Animal Control Officers, and New Jersey State-licensed trappers; and

**WHEREAS**, New Jersey Animal Control provides domestic animal rescue, wildlife trapping, and both live and dead animal removal; and

**WHEREAS**, funds are available for this purpose; and

**WHEREAS**, the Township of Lumberton, pursuant to N.J.S.A 40A:11-1 et seq. is permitted to award contracts which are under the \$6,000 quote threshold due to having employed a Qualified Purchasing Agent; and

**WHEREAS**, the Township of Lumberton has a desire to award a contract not to exceed \$6,000 to New Jersey Animal Control to perform as needed Animal Control Services when Lumberton Township's appointed Animal Control Officer is either away on leave or unavailable to perform those services, with the rates of service hereinto attached to this resolution for a period of one year ending December 31, 2016; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Lumberton, Burlington County, New Jersey, that the Mayor and Township Administrator are hereby authorized and directed to execute said Agreement on behalf of the Township a contract not to exceed \$6,000 to New Jersey Animal Control to perform as needed Animal Control Services
