RESOLUTION AUTHORIZING THE AWARD OF A BID AND EXECUTION OF A CONTRACT BETWEEN THE TOWNSHIP OF LUMBERTON AND TR WENIGER FOR THE RANCOCAS CREEK ACCESS IMPROVEMENTS

WHEREAS, the Township of Lumberton, through its Engineer, Pennoni Associates, Inc., solicited bids for the Rancocas Creek Access Improvement Project; and
