

TOWNSHIP OF LUMBERTON, NEW JERSEY

ORDINANCE NO. 2018-01

AN ORDINANCE TO PROVIDE FOR AND DETERMINE THE RATE OF COMPENSATION OF OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF LUMBERTON

WHEREAS, the Township adopted Ordinance 2016-13 to establish salary ranges for municipal position and annually adopts a Resolution fixing the range of compensation of employee; and

WHEREAS, a review of that Ordinance has determined that certain positions have been changed or consolidated and require amendment, along with increases to salary levels;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Committee of the Township of Lumberton, County of Burlington, State of New Jersey, as follows:

1. All prior salary ordinances are hereby repealed and have no legal effect.
2. Article I and II below are replaced as follows:

ARTICLE I. Amended Sections.

- A. Section 1 of the Ordinance of which this ordinance is amendatory is hereby amended and supplemented as follows:

“The minimum and maximum rate of compensation of officers and employees whose compensation shall be on the annual basis payable quarterly shall be as follows:”

D. All the minimum and maximum salary ranges listed in Sections A through Section C are effective to January 1, 2018.

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
